

BGCNC Technology/Chromebook Usage Parent and Member Permission Form

Any parent who wishes for their child to use a Nassau Club electronic device within the Boys & Girls Clubs of Nassau County must read, sign, and submit this agreement to Club staff. Devices will only be used during Club-sanctioned programs that require devices to be used.

- 1. In order to use the Boys & Girls Club technology/chrome book services, members and parents must review and sign the Acceptable Use Policy. This is considered a legally binding agreement.
- 2. Members will take full responsibility for Club device and keep in program areas at all times. Members may sign out/in their device and must not loan to any other Club member. The member/parent/guardian is responsible for the security of the device or loss/damage/theft of a BGCNC Club owned device.
- 3. Members/Parents/Guardians are responsible for the proper care of BGCNC Club device, including any costs of repair, replacement, or any modifications.
- 4. Members should only use the device to access services, networks or files relevant to Club-sanctioned programs. Members should only use the features of the device, including, but not limited to, taking or transmitting pictures, videos, location information or other in accordance with program offerings.
- 5. Members may not use the device to access, share, display, or record materials that are obscene, offensive, inappropriate or contain foul language.
- 6. Members may not use the device to record, transmit or post pictures, videos, or other information of or about a person or persons at the Club. Nor can any images, videos, or other information recorded at the Club be transmitted or posted at any time without the express permission of Club Service Directors.
- 7. Members must comply with staff requests to shut down or turn off the device when asked. Failure to do so may result in the member being barred from using BGCNC Club devices in the future.
- 8. Violations of any Club policies, administrative procedures or Club rules may result in the loss of use of the Club device at the Club or disciplinary action.
